#### The Purpose of Each Parochial Church Council in the Benefice

Each Parochial Church Council (PCC) is a charity excepted from registration with the Charity Commission.

The PCC (Powers) Act 1956 states that the PCC 'is to cooperate with the minister in promoting in the parish the whole mission of the church, pastoral, evangelistic, social and ecumenical'.

The method of appointment of PCC members is set out in the Church Representation Rules 2006.

#### The Rector's Report

It has been a year of momentous events for us as a country: The Queen's Diamond Jubilee and the London Olympics are the stand out national occasions that have given us a sense of community across the country. Some think that it will be a hard year to follow, not least because of the superstitious number 13 but thankfully we do not have to look to such nonsense as I look back on another very busy year in the life of this Mission Community. I use the words 'Mission Community' rather than 'Benefice' because we are now on a path which the Mission Community Council (MCC) has endorsed that we work towards becoming a Mission Community comprising a United Benefice rather than two separate legal entities as we acknowledge that what we can do together is greater than the sum of the things we can do separately.

The MCC has set up 5 groups that are working through our aims and objectives that we agreed in September. This will be an on-going programme that will roll on from year to year as we seek to extend the kingdom of God in West Dartmoor. There are many challenges that we face, some of which I will mention in due course, but my overall sense is one of being thankful to God for his goodness and faithfulness and for the numerous ways in which we have been able to proclaim Christ Jesus.

#### **Comings and Goings**

We welcomed to the ministerial team:

*Revd Capt Gary Shirley* as Associate Priest working across the whole Mission Community in October and as Gary finds his feet in his new role we look forward to receiving many blessings as a result of his ministry. We also welcome Carol, Gary's wife and Thelma, Carol's mother as they settle into their new life in Horrabridge.

*Revd Mike Fairall* as self-supporting Priest with permission to officiate (that means Mike is working with us in his retirement). Mike has years of experience in ministry in this part of Devon and we are very fortunate to have him join the team. We also welcome Marie, Mike's wife.

*Revd Andy Barton* as curate in training. Andy was ordained in September and will be with us for 3-4 years. We pray that his ministry will flourish so that, in due course, he will be equipped to take on his own role of responsibility elsewhere within the church. We also welcome Sioned, Andy's wife and Tom and Hannah their children.

We have also said some goodbyes:

*Revd Jill Locock* has retired from active priestly ministry as at 31<sup>st</sup> December. We will miss Jill's expertise in the team but wish her every blessing in her well-earned retirement. Thankfully Jill is not moving away and will be still worshipping with us as Roger, her husband, continues his ministry as a Reader.

*Revd Peggy Salmon* is moving to Tavistock Parish Church to make her spiritual home there, having spent 25 years working in these parishes. Again we wish Peggy every blessing in her new role.

#### **Structural matters**

'If you find the perfect church don't join it or you'll spoil it' is an old joke but underscores a truth that God's Church is always in need of reformation not least because it is full of people like you and me: servants of Christ who constantly need God's love and forgiveness. We are living in difficult times where our parishes face pressures: people pressures as we struggle to find people who want to stand as church officers and as we realise that the age profile of our congregations continues to be at the upper end of the age range. Financial pressures as some parishes, despite huge efforts, are not able to pay their way.

The Diocese of Exeter is not immune from these pressures and in 2012 faced a £600,000 hole in their budget. This has led to redundancies, vacancies in parishes being extended and the number of stipendiary clergy in post being reduced. We have lost the use of some vital people who have supported us in the past. We have a half time post still vacant in this Mission Community and I see little prospect of it being filled quickly.

Tavistock Deanery has also been looking at its structure as the Deanery Pastoral Committee has put forward a number of matters for consideration by the Deanery and those consultations are ongoing.

These changes will mean that we will have to look at our ecumenical partnerships in 2013, as the paperwork no longer reflects the reality of what is happening on the ground both in Princetown and Horrabridge.

It is against this background that we are working to form a Mission Community. This year, on 1<sup>st</sup> April, Princetown Parish was dissolved as an ecclesiastical parish. The two daughter churches have joined the Moorland Team and Princetown itself is now part of the parish of Walkhampton. So whereas we started the year with a 7 parish Mission Community, we end it with 6 parishes.

#### Signs of the kingdom

First, I want to say a thank you to everyone who is involved in the faithful weekly delivery of services across the Mission Community in each of the parishes. This is the backbone of our worship, all too easily taken for granted, but vital to our spiritual health and well-being.

Then there are a number of other key areas of ministry that are worthy of note. When we put on an 'event' they are extremely well supported by the wider community but what has so far eluded us is turning the 'event-goers' into disciples of Christ who want to be committed to a pattern of life modelled for us by Christ as part of their day to day way of being. So we can pack people in for Christingles, Remembrance Sunday, Carol Services, Harvest Suppers and the like – and thank God for that – but this has had little impact (as far as I can see) outside these events.

So we are building on these events and offering a wide variety of services and ways in which we can extend the kingdom: Ladies' Lunches; Men's Breakfasts; Healing Services; Bible Studies; <u>Nosh@9.30</u>; Lighten our Darkness (a service for the bereaved); engagement with schools in Collective Worship; Crib Services; Supper

Evenings; Lent Courses; Occasional Offices (baptisms, weddings, & funerals); Choral Evensong supported by our choir drawn from across the Mission Community; midweek services; Mother's Union; coffee mornings; flower festivals; work in retirement homes, nursing homes and sheltered accommodation; pastoral visitors; worship teams; magazines; website; I could go on and you can read about all the good work that goes on in greater detail in this report.

Yet all this activity is no substitute for a relationship with God. It is out of our calling as human beings, made in the image of God, that we can do the 'human doing'. Without this sense of relationship with God then, as the psalmist reminds us, we build our community in vain. Any programme however extensive and well thought out has to be undergirded by the two great commandments to love God and our neighbour as ourselves.

Once again I want to thank everyone who has worked tirelessly with little or no recognition or reward through the past year in so many ways.

#### **Deanery Synod Report**

There have been three meetings; in February, June and July. There is a presentation on a specific topic followed by the business part of the meeting.

In February the speaker was Sally Farrant, a member of the diocesan staff who works mainly for the Council of Church and Society – where the church interfaces with the needy in our society.

The June meeting was a joint meeting of the Tavistock and Okehampton Deanery Synods and the presentation was on `Reaching Families`. The speakers were Anna Norman-Walker (Diocesan Missioner) and Katherine Lyddon (Diocesan Children`s Work Advisor).

The October meeting focussed on the work of the Deanery Pastoral Committee which had been reviewing the deanery plan. Revd. Preb. Nick Shutt, chairman of the recently reformed committee, gave a presentation on its discussions. Mission and growth were priorities; form must follow function and consultation was required. A response from the parishes was asked for by Easter. Annie Inman.

#### **Benefice Choir**

The choir led the singing in Mission Community services each month in 2012 and met together 50 times during the year. A modern composition written for the choir by Chris Shutt, as well as a Sea Sunday hymn written by Graham Kendrick in 2012 and the Jubilee Song by Gary Barlow were part of the choir's repertoire.

Mission Community services were held at Princetown, Meavy and St Paul's Yelverton. The choir also sang at the retirement service for Rev Nicola Hunt in St Paul's and the Licensing of Rev Prebendary Nick Shutt and Rev Gary Shirley in St John's Horrabridge. Good attendance was made by choir members at Evensongs, Healing services, 'Songs of Praise', 'Lighten our darkness' and for the Sea Sunday service. New and old hymns from 'Sing Praise' were sung at the Advent Carol service in St Paul's. Christmas Carol services in candlelight at St Michael's Princetown (accompanied by the Salvation Army band), St Paul's Yelverton and St Leonard's Sheepstor were led by the choir.

Entertainment by the Benefice Choir at the popular supper evenings, the dedication of the Queen's Jubilee sundial at Roadford and Christmas Carols at the Walkhampton Inn and the Moorland Garden Hotel was enjoyed by members. Choir practices are social meetings, many followed by food and drink. We look forward to joyful singing in 2013 and always welcome new members to the choir to lead the singing at services in the Mission Community and at other events and venues.

#### **Church Schools' Report**

This year has been a very exciting one for the pupils and staff of Lady Modiford's and Meavy Primary Schools which together make up the West Dartmoor Federation.

The infectious celebrations for both the Queen's Diamond Jubilee and the Olympic games spread to the children. Both schools had lovely Jubilee 'garden parties' and then came together for a mini Olympics. Children from both schools ran a torch from Walkhampton to Meavy where the schools mixed together for an afternoon of sporting activities. Everyone had a great time and it helped to cement the growing links between the schools.

Our aim is to keep the unique distinctiveness of both schools under the umbrella of the Federation. This has meant that on occasions each school will hold an event of their own and at other times we will have special joint events. The Reverend Nick Shutt and his team organised a church service to celebrate the federation and the appointment of the executive headteacher. This was held at St Paul's Church in Yelverton and there was a great turn out by parents, children and friends of both schools. We intend to make this a regular event and everyone will be warmly welcome to join us.

Lady Modiford's nativity celebration differed this year from previous performances and appeared on BBC Spotlight! The staff organised a travelling version of the story which moved around Walkhampton village, St Mary's Church and the school. There was even a small pony for Mary to ride! This was a delightful afternoon where the importance of the birth of Jesus was reinforced by the children acting the parts and 'living' the story. There was a huge turn out to walk with us and it was a great way to mark our Christmas celebrations.

More recently, both schools took up the opportunity to take part in the chorister outreach programme run in Exeter Cathedral. After several rehearsals at school, children from the federation joined other school groups in singing in the cathedral on a Saturday afternoon. The cathedral was packed and there was not a dry eye in the place such was the impact of wonderful singing.

The federation is close to the beginning of its very exciting journey and we hope many of you will be able to join us at various times to support and enjoy what we do. Please take the opportunity to come to our services and events throughout the year; you would be most welcome.

## Report of the Parish of St Paul's, Yelverton in 2012

#### **PCC Meetings**

The PCC has met 6 times during the year. Among other subjects discussed were: the rationalization of services across the larger mission community, the quinquennial inspection.

The difficulty of heating the large and high area in the Church was followed up by a Churchwarden's visit to St Stephen's, High Street, Exeter. However St Stephen'sChurch was found to be smaller than St Paul's and had a lower, and very well insulated, ceiling, and could not be compared. St Paul's Church Hall is usually available for worship in extreme weather conditions.

During the year, cream teas organised by Sheila Stacey were a great success. The hire of the church for concerts by Plymouth University and the Dante String Quartet was also successful. The joint harvest supper with Holy Cross roman catholics and Rock methodists was enjoyable, and the Devon Historic Churches Fund was supported by parishioners. The weather for the well-organised fete was good and the Alms and Oblations Committee has made grants totalling £1260 to missions and charities.

The PCC wishes to express its thanks: to Nick, particularly, and the other ministers for their work on behalf of the parish and mission community, particularly Peggy Salmon for all her help over 25 years, and Jill Locock, who is retiring through ill health; to the congregation for its support and co-operation; and, to all those who help in so many different ways.

#### Fabric Report 2012

The lightning conductor has been inspected by Dawsons. The gutters and down pipes have been cleared, the organ and piano tuned, the boiler serviced and a new boiler door fitted. Carpets by the altar have had most of the candle wax removed, and the font cover and a side table have been renovated. Details of Team Rectors on the internal Church notice board have been updated.

Unfortunately, before Christmas there was a theft at the Church, which caused significant loss. Subject to this, the goods and chattels have been checked, and are substantially in order.

#### **Treasurer's Financial Review**

After a series of difficult years the financial outcome for 2012 showed a distinct improvement with a surplus of £3,652 compared with £253 in the previous year.

This improvement arose from a number of features. First, and most encouraging was that regular giving from monthly bank standing orders and weekly envelopes showed a material increase, with a number of new members and some increase from existing members more than outweighing that lost from departing members, resulting in an increase of nearly £3,000, and I take this opportunity of thanking everyone for their giving. I can also note the frequent receipt of generous donations, many from parishioners who no longer find it easy to attend church services, and totalling more than £1,200. Again many thanks.

We were really pleased to hold our church fete again this year, which raised the magnificent total of  $\pounds 1,259$ , all of which went to support our chosen charities.

Miscellaneous income of £1,270 came principally from two sources. £821 was the result of three highly successful cream teas put on by Sheila Stacey and her wonderful helpers. The other main contributor is the use of the church for concerts, which lends itself really well for this purpose.

On the expenditure side, our contribution to the mission community expense budget was lower in this transitional year, but is likely to increase over coming years with the enlarged group of clergy. Although classified in our accounts as clergy expenses, the activities funded within the MC extend much more widely than that, but many of the new activities are largely self-funding and do not put a strain on parishes.

Heating and lighting is a little down, but only because we delayed our final delivery of oil until the new year. We did, however, have a rather busy year with R&R; the quinquennial inspection, repair of broken guttering, boiler repair and some much needed surgery on the trees overhanging the entrance gate and wall in front of the church all cost sizeable amounts.

The diocesan common fund contribution again fell a little, reflecting our decline in numbers. Valuable though this reduction is, we would much rather have a significant increase in our numbers at services and meet the consequent higher rate of contribution.

Finally, I can report on another successful year for the church hall. With the continuing very satisfactory usage, the income is good enabling us to afford regular maintenance. Of most note is the long overdue paving beside the entrance and replacement of rotted panelling. Despite this material expenditure the hall produced a surplus in excess of £1,500.

It is good to be able to report on a satisfactory year, and I thank all our parishioners for playing their part in this.

#### **Fabric Report**

The quinquennial inspection was due this year and duly took place in August. # Annual Report of the Parochial Church Council (PCC) for the year ended 31 December 2012

#### **Administrative Information**

St Leonard's Church lies at the centre of the seventeen dispersed houses and farmsteads which make up the village of Sheepstor. It is part of the united Benefice of Yelverton, (itself within the West Dartmoor Mission Community), which is in the Tavistock Deanery of the Church of England Diocese of Exeter.

The PCC is a charity exempted from registration with the Charity Commission.

#### **Structure, Governance and Management**

The method of appointment of PCC members is set out in the Church Representation Rules. All church members are encouraged to register on the electoral roll and stand for election to the PCC.

#### **Objectives and Activities**

St Leonard's PCC has responsibility for working with the incumbent, the Rev'd Nick Shutt, in the Parish, and with other PCCs and the Mission Community Council, in promoting the whole mission of the Church, pastoral, evangelical, social and ecumenical within the Mission Community. The PCC is responsible for the care and maintenance of St Leonard's church and churchyard.

#### **Review of the Year**

#### **Church Attendance and Services**

The electoral roll rose to 18 of whom 11 were not resident in the parish, and two left the village during the year.

We held services on every Sunday apart from Benefice services on 5<sup>th</sup> Sundays in the month. The average church attendance counted in October rose from 9 to 10, but this increased significantly for church festivals and special services such as the carol service, at which this year we had 140 people in church. Other large congregations came together for Good Friday, our thanksgiving service with staff and students from the University of Plymouth for the mission project on 20 May, harvest festival and services for baptism, weddings and interments of ashes.

We were able to welcome to services during the year both the Archdeacon, the Venerable Ian Chancellor, and the Diocesan Missioner, Revd. Preb. Anna Norman-Walker.

We again hosted the Good Friday walk of pilgrimage, with a short service at St Leonard's and the carrying of the cross to the top of the tor behind the church. The PCC offered its traditional hot Palestine soup and hot cross buns in St Leonard's room afterwards.

The harvest service again drew a good congregation and the supper was held in the church hall, following its successful restoration.

The carol service was held by candlelight with traditional refreshments afterwards in the village hall. It was the largest church congregation for which we can find recent record.

#### **Occasional Offices**

In 2012 there was one baptism, of the son of a couple who were married in the church two years ago. There were six interments of ashes, including those of the Brooke family mentioned below. There was one funeral, two weddings and one blessing of a wedding.

#### Visitors

The connection of the village of Sheepstor with the Rajahs of Sarawak, from the Brooke family, whose tombs and graves of family relatives lie in the churchyard, was given renewed emphasis during the year. The ashes of Anthony Brooke, the last Raja Muda, were interred in the churchyard along with those of his daughter following a memorial service in the church. A large number of family members attended as well as well wishes of Sarawak. The Sarawak national anthem was played, possibly for the first time since Sarawak came under the British crown in 1946.

We continue to give a major emphasis to our mission to visitors of whom we have many, drawing on Sheepstor's wonderful position as a gateway to Dartmoor, its proximity to Burrator Reservoir, its featuring in the film "War Horse", and the links to the Brooke family and Sarawak.

During the year our new audio welcome installation enhanced our ability to welcome visitors and explain the church and its role. We had been successful during 2011 in obtaining funds for a mission project from the Diocesan Million for Mission

Fund. In partnership with Plymouth University we developed this audio welcome which offers 6 recorded stories about the church and its use to welcome visitors. This went live on Easter Day. Its evaluation showed warm support from the congregation and from visitors.

#### **Leading Worship**

The clergy group this year welcomed Revd. Gary Shirley as Assistant Priest, Revd. Andy Barton as Curate, and Revd. Mike Farrell as a non stipeniary member of the clergy team. Sadly, Revd. Jill Locock decided to withdraw form active ministry leading services and Revd. Peggy Salmon decided to move the focus of her ministry to Tavistock. The first Sunday in the month continued to be led by lay members of the congregation who read the service, gave talks and led intercessions and the worship group will continue to develop and lead these services over the coming year. Congregations remain very encouraging to the worship group's efforts.

Cdr. Tim and Mrs Drinda MacDonald left the village during the year, having decided to move to east Cornwall. They are already sorely missed. Drinda had been the key lay leader of the church for nearly 20 years, being a churchwarden for over 15. Throughout that period she had played the organ for the church and led the development of music in our worship. She has left a wonderful legacy in new embroidered altar frontals, chalice veils and burses as well as Christmas decorations. Tim had been the treasurer and led the management of church maintenance for most of this time and more recently had lead our morning prayer services, reading the service.

With Drina's departure we were fortunate to gain the support of Tony Dando who has become our organist as well as occupying the same role at Walkhampton. We have introduced a supplementary hymn book based on the hymn sheets which Drinda introduced us to and this extends our singing into some of the modern canon as well as a range of old favourites.

The PCC continues its active policy of support for women in the priesthood and in leading worship. It has been disappointed by continued delay in the progress towards appointing women bishops.

#### **Benefice and Mission Community**

During the year the West Dartmoor Benefice expanded to join with Horrabridge and Sampford Spiney. A single Mission Community Council operates over the two benefices affected to lead work on mission and growth. St Leonards strongly supported this developing co-operation across the mission community and would wish to see similar links develop between Anglican churches and ecumenically in the area of the Tavistock Deanery.

#### Meetings and Non Worship Activity

The PCC met four times during the year under the chairmanship of the lay vice chair, Cdr MacDonald until the AGM and thereafter Mrs M Bennett.

The maintenance committee met as needed under delegations from the PCC and reported major issues to the PCC. A significant step forward in the development of the church was achieved when the old organ was finally removed and the space left was renovated through the considerable work of members of the village. Plans are now being developed for the future use of this space in partnership with the Friends of St Leonard's. This project is likely to require significant repointing of the exterior of parts of the Church in line with the last quinquennial survey.

The Friends also helped run a work party in the summer which contributed to the Churchyard looking tidy and well-kept in keeping with principles of sustainability.

#### **Treasurer's Report - Financial review**

This year has seen an upturn in our financial fortunes, although, in part, of a temporary nature only.

Total receipts rose by over £2000 (35%) whilst expenses fell slightly giving a balance of receipts over payments of £1519 against a shortfall of £248 in the previous year.

Planned giving rose by £105 (8%) overall - attributable mainly to the envelope scheme. Gift aid tax recovery fell in line with the revision of the tax regime whilst there was no movement in the banker's standing order scheme. This prompts us to promote this latter method of giving with greater effort in the coming year.

The pattern of casual cash giving showed little movement. Church collections of over £800 again suggest further scope to recruit to the standing order scheme.

Our thanks are due once more to the Parish Council for their annual grant towards upkeep of the Churchyard and especially for a generous increase over the previous year.

We were asked to provide more pastoral services than in a typical year - two weddings, a funeral and burial, six interments of ashes and five memorials - this windfall brought in £1100 in fees and £200 in associated donations. Income from fees is typically very erratic with large year to year differences - we certainly cannot expect a similar income from this source on average over future years. Against this background and for planning purposes our assumed income should not include this source.

We have held three significant events during the year each of which resulted in generous giving from those attending. We were privileged to host the District Ringing Competition and most grateful for the  $\pounds$ 274 donations received from competitors and their supporters. Our Harvest Festival service and supper resulted in voluntary contributions of  $\pounds$ 386 - this was passed to the Benefice Treasurer in support of Farm Africa and Tavistock Food Bank. The annual carol service was attended by a capacity congregation of 140 souls resulting in collection and food donations which together totalled  $\pounds$ 346.

Income from investments remained disappointing, due both to low investment rates in general and to the restraints imposed on PCCs in particular. Our investments with the CCLA which stood at approximately £43,000 at the beginning of the year brought in only £1,030, equivalent to 2.3%.

The pattern of expenditure remained largely unchanged, major items, as usual, being the common fund payment, insurance and upkeep of the Churchyard.

The year has seen minimal exceptional expenditure. Minor repointing of the roof upstand flashing being the only significant item. First stage refurbishment and redecoration of the Lady Chapel, vacated by the pipe organ, has been completed in part with voluntary labour. Our grateful thanks are due to those who gave their time

and not insignificant effort to complete this work in time for a wedding in early December.

This year we have made no donations to charity other than the Harvest Festival collection.

Whilst we have had a good year financially, this is no cause for complacency. The increase in income was due almost entirely to 'one off' events with little movement in our regular sources. Whilst routine costs are unlikely to increase significantly in future, there remains much work identified by the quinquennial inspection, together with completion of the Lady Chapel refurbishment. We are in discussion with the Friends of St. Leonard's concerning the latter.

It should be noted that in accordance with charities accounting practice, deposits and receipts not cleared at the year end together with amounts owing and payments not cleared at year end are excluded from the figures described above. Likewise these amounts from the previous year are included. Please see the statement of assets and liabilities for more detail.

## Report of the Parish of St Mary the Virgin, Walkhampton in 2012

Members of P.C.C. – Jim Knight (Lay Vice Chair), Mike Dobson (Churchwarden), Mary Geen (Churchwarden), Chrissie Brannagan (Secretary), Kevin Baxter (Treasurer), Kay Miall, Mavis Goddard, Derelie D'Oyly, Sarah Tuck, Tony Dando.

The P.C.C. met three times during the year and there were four extraordinary meetings. During this period, Mary Geen stepped down from her churchwarden and P.C.C. roles owing to ill health. Jim Knight was unable to attend all meetings for the same reason. Tony Dando was co-opted in September. David and Christine Lenthall were approached with a view to being co-opted in January 2013.

The regular 9.30a.m. Sunday services were re-scheduled for 9 o'clock as part of a move to enable members of the ministry to cover all their responsibilities. When 'Nosh at 9.30' was introduced it was decided that there would be no service on the 3<sup>rd</sup> Sunday in the month.

Once again the harvest supper was a joint event with Lady Modiford's School, with the children preparing soup and rolls.

The Remembrance Sunday service, attended by the Cubs and Beavers, was held in the Memorial Hall prior to gathering around the cross for 11a.m. About 120 people attended.

During the summer months, the church was opened on one afternoon each week and was visited by walkers and other casual visitors.

After what seemed to be a long time, the faculty for the west-end re-ordering was granted, despite there being some issues about the design of the screen. Some pews were removed to enable an examination of an area of the flooring.

### Receipts

The regular Giving has dropped this year from £14,285 2011 to £12,978 in 2012. With a loss of one service a month and the reduction of tax reclaim this has reduced our income. If you ignore the fundraising for WERF we have increased monies by 11.5% for the day to day running of the Church

#### **Payments**

This year we have spent  $\pounds 6,353.00$  less than last year biggest cost been  $\pounds 4675.96$  to the architect. Common fund went down from  $\pounds 10,711.00$  to  $\pounds 10,595.00$ . Fuel bill went up approx  $\pounds 500$  more this year.

Ignoring WERF monies in and out for general running we are down by  $\pounds 1,039.57$ 

#### Total Assets

The overall asset position for the Church at the end of 2011 was  $\pounds 174,972.61$  and this has increased to  $\pounds 178,189.87$  in 2012. However, of this sum  $\pounds 137,488.11$  is earmarked for West End Reordering Fund

#### **Health & Safety Report**

The new font cover was installed early in the year, with the old cover retained, behind the organ.

#### **Churchwarden's Report**

The Church opening programme during the months of June to September ran again thanks to the support of congregation members and some villagers. Visitor numbers were down on the previous year, due to the extremely poor weather.

Repairs were made to the organ, because of a siphoning problem and it also had its annual service. In addition the annual inspection was carried out on the fire extinguishers and lightning conductors. A full electrical survey was carried out in readiness for the quinquenial and this revealed that in order to comply with the current regulations, upgrading of the earthing wiring on the boiler, organ and main switchboard was needed. This work was completed in December.

In late summer a section of the flooring in the north aisle was lifted; so that a photographic record could be sent to the DAC to support our faculty application for the WERF project. Conditional approval was received from the DAC for the WERF project in late autumn and the issues raised by them are being dealt with to obtain full approval for the project.

In October work was carried out in the Lady Chapel to remove the wooden plinth and the curtains surrounding the altar. This was then moved forward to make it more functional.

Finally to help improve the lighting in the church, some new types of bulbs were installed over the main altar area. They are not only low energy but have also made a significant improvement to light levels. The plan will be to proceed with the introduction of these bulbs in the rest of the church as and when we run out of the old type bulbs.

**Restricted Funds.** Restricted Funds are funds raised and set aside to fund works in creating a new kitchen.

**Investments.** During the year investments held for the J Chichester, Mrs A F Binning-Monro, R Credicott and W R Northmore legacies were sold. As each legacy was a separate trust having a value of less than £10,000, advantage was taken of the provisions of the Charities Act 2006 enabling small trusts to be wound up. In accordance with the regulations the proceeds were used to reimburse general funds which had been depleted by expenditure on the objects of those trusts.

# Structure, Governance and Management

The method of appointment of PCC members is set out in the Church Representation Rules. All Church attendees are encouraged to register on the Electoral Roll and stand for election to the PCC. The full PCC meets at least 4 times per annum. With the increasing influence of the West Dartmoor Mission Community the PCC decided to elect Simon Hill as its Lay Chairman for the foreseeable future.

### **Objectives and Activities**

The rhythm of church life and worship has continued much as before, and we have adjusted over the year to the implications of being a part of the Mission Community. Simon Hill and Ros Pugh have represented the parish at Mission Community meetings, supported by Helen Sims. Wider PCC members have also made considerable efforts to engage with Mission Community meetings.

The PCC was delighted by the arrival of Rev Gary Shirley as Associate Priest living in Horrabridge Rectory and by the appointment of Rev Andy Barton as Curate living in Yelverton Rectory. The licensing of Rev Nick Shutt as Priest in Charge and Rev Gary Shirley as Associate Priest on 14 October was greeted with great pleasure and relief that a period of uncertainty and excessive work pressure on Rev Nick Shutt had been brought to a very satisfactory conclusion.

Representatives of the PCC are working in Mission Community Task & Finish Groups led by our clergy in addressing Safeguarding/Bus List (Helen Sims) and Finance, Conservation and Tourism (Simon Hill). The main challenge in 2013 will be to develop a Mission Community Plan for submission to the Deanery – at a Mission Community wide meeting all felt that this was the right level to start such planning.

Our fund raising activity will be reported separately.

## **Church Attendance**

There are 26 parishioners on the Church Electoral Roll. The average weekly attendance was 10, with increased attendance at Easter at 17, and over the Christmas period at 54. Of particular note was the Good Friday service attendance of 27 to which many children brought their parents and grandparents. During the year there have also been 2 marriages and 1 funeral.

## **Church Warden's Report**

Immersion in the Mission Community has brought some changes notably the service readings and Epistle have been changed to fit in with Horrabridge otherwise the clergy involved would have to preach two sermons. That said, we continue to use the King James Bible, except for Baptisms where the Common Worship version is used.

The number of people attending church services is falling and, although this is in line with the general trend across the country, it is something we will need to think hard about as the regular participants and communicants are the life blood of the church.

On a more positive note, we have a good variety of people taking our services and plans are being made to strengthen the pastoral team.

The number of people caring for and doing minor works on the church and churchyard continues to grow, for which we are very grateful. The new cover to the side altar is a big improvement; it was only on its removal that we realised how very worn the old one had become! The next minor items that need replacing are the Christmas tree decorations.

Many have commented on the positive atmosphere and welcome at St. Mary's Church which we hope will encourage others to join us for a service from time to time. All comments and feedback are listened to and we need both church goers and parishioners to keep us informed of those in need of help or a pastoral visit.

We continue to see a steady flow of visitors to our church and will be looking into how we can present the history of our church and community in an appealing and fresh way,

## **Review of the Year**

It was a matter of great sadness that we lost one of our most loyal and dedicated parishioners in 2012 – David Sommerfelt will be sorely missed.

With the support of the Bishop of Plymouth and the hard work of Rev Nick Shutt concerns over our ability to recruit new clergy for the Mission Community were not realised. As Priest in charge the latter continues to arrange our service takers for which we are most grateful. We hosted the Mission Community Fifth Sunday service this year with a full church for Book of Common Prayer (BCP) Holy Communion.

As always we are hugely dependent on the goodwill of our parishioners namely:

Our bell ringers who ring on special occasions and First Sundays

David Crocker, our loyal organist

Peter Badge continues to manage the rota for readers and sidespeople.

Mary Badge and her team continue to organise the flowers.

Helen Sims looks after the church linen and brass and acts as sacristan when necessary.

Peter Walde continues to look after the new churchyard and keeps the paths tidy.

A-J Charlesson who has managed the Easter, Christmas and Harvest Festival set ups

We continue to be very blessed with enthusiastic and committed fundraisers who contribute hugely to the life of the church – Mike Doidge ran the Harvest Supper and Auction and Helen Sims once again masterminded the Christmas Extravaganza which together raised over £3000. We were also most grateful for the donation from the annual Sheepdog Trials which raised £500 despite appalling weather and for Ros Pugh's efforts in raising £600 at the Curry Lunch and some £200 + from jam and marmalade sales at the church door. These activities raised much needed funds, as well as being very enjoyable and drawing into the life of our church many who would not normally attend services.

### Fabric

Our community has an excellent reputation for looking after the fabric of our church and we are currently striving to raise enough money to repair our tower and replace our electrical/ heating system, at a combined cost of some  $\pounds 60,000$ . We very much hope to be able to complete this work in 2013. In the first 6 months of our fundraising campaign, we are most grateful for the following donations:

£5000 from the Garfield Weston Foundation £2000 from the Devon Historic Churches Trust £1000 from the Allchurches Trust Ltd £9221 from the community of Sampford Spiney

We have a bid lodged with the Church Buildings Council for  $\pounds 5000$  and intend to bid for a smaller sum to the Veneziana Fund in February. The Heritage Lottery Fund has encouraged us to bid for  $\pounds 20000$  and that process is underway – this bid will include  $\pounds 5000$  with which to interpret the history of the church and its community.

In addition the PCC has its usual programme of events planned for 2013 plus a guitar concert, a wine tasting, an art exhibition, a flower festival and a parish barbecue and raffle.
